---

# Academy Curriculum

---

Hafs Academy has decided to call its curriculum '**The Balance**'; the reason for this is because of our intentions of combining Islamic education with the national curriculum education to give students a deeper insight in to both strands of knowledge.

It is really important and necessary to understand that whilst studying Islamic education, a good level of 'tarbiyyah' (Islamic nurturing) and 'tazkiyah' (self-purification) is required, so that one is able to receive the full benefits from it, however the fundamental aim of studying Islam is to achieve the Fear of Allah and the Love of his Prophet which in turn will lead to an individual having the correct understanding and comprehension of Islam.

The internal capacity of each Muslim must be nurtured and purified so that he/she studies Islamic knowledge with the sole intention of pleasing one's Creator and seeking nearness to him; this is what we call 'ikhlaas' (sincerity). The required self-purification can be recognised when an individual has a complete dislike to indulging in any type of misconduct but on the contrary he loves to be in the remembrance of his Creator and exhorts himself to follow the Sunnah of our beloved, most honourable Prophet Muhammad (peace be upon him).

The required tarbiyyah can be recognised when an individual's character becomes very pleasing to the people as well as to Allah. The character and manners of a person is very important for him/her to be able to progress in life and there is no better example than the character of the last and final Messenger, Muhammad (peace be upon him).

Both of these qualities cannot be achieved without the help of the Parents. The home environment of a child is vital in him/her being able to fully practice Islam and being able to study Islamic or state education with full concentration.

Indeed, in the early generation of Muslims i.e. The companions of the Prophet (peace be upon him) and those who came after them, we have an excellent example of how we as teachers and students should conduct ourselves to achieve the greater benefit from every task we undertake keeping in mind the sincerity of our intentions.

English as an Additional Language Support:

In accordance to the academy's commitment to provide support for the pupils who have difficulty in English, the academy will work together with English teachers to provide additional support for these pupils in the following ways: -

- 2) Withdrawal for intensive work on basic literacy skills.
- 3) Ensure that programme of study and the materials used to deliver them are suited to the pupils' needs, enabling them to achieve and progress.

# Attendance and Punctuality

---

Regular attendance and punctuality is essential for every child's educational development. If your child is unable to attend Academy for any reason please telephone the Academy, send in a note or speak to an academy staff member in person explaining the reason for absence. Regular unauthorised absences will not be tolerated and can result in a social welfare officer becoming involved.

## Procedures:

- Registers are marked at 8:00am; any child who arrives after this will be marked as late
- When a child is absent from Academy, the Academy must be informed as soon as possible and a reason must be given to why the child was absent
- Where attendance is not regular or not to the Academy's expectation you will receive a letter from the Head Teacher. If concerns continue, a welfare officer will have to get involved and your child's attendance will become a legal issue
- A record of your child's attendance will be included in their annual report
- Holiday's during Academy time will not be authorised

# Academy Rules

## Record Keeping:

When any child is involved in any serious incidents such as fighting, disrespecting a teacher etc then these details will be recorded in the child's folder. Parents will be informed and may be called in to discuss the incident according to how serious it was.

# Academy Admissions

---

We are always pleased to meet and show prospective parents around the Academy building and give them a briefing of how the Academy timetable is managed throughout the day.

Please call to book an appointment before coming so that a senior member of staff will be available to discuss with you any questions and issues you may have otherwise if you are just interested in viewing the Academy building then booking an appointment is not necessary as the academy's Administrator will be available to show you around.

The admissions policy is as follows:-

- Parents must fill in an application form and submit it to the Academy's office with a copy of the **student's passport** or **birth certificate**, **picture of student** and their **full Academy report** for the previous academic year.

Please Note: There is an initial registration fee of £250, which must be submitted with the application form

- The enrolling pupil will be required to sit an initial assessment so that the academy may identify his level of learning; this will not affect the child's enrolment in any way.
- The annual academy fee can be subject to change in the coming academic years. See current fees policy.
- Please discuss the full admission procedure and payment of Academy fees with a senior member of staff when enrolling to be sure there are no misunderstandings.

We recognise and understand the fact that parents are giving the Academy a trust when paying for their child's Academy fee therefore we guarantee that we will do our best in all aspects to make sure the child receives a quality level of education, Insha Allah.
